## ***Renting Conditions***

1° **Bookings are made for a week:** from Saturday afternoons from 2 p. m and before 18 p. m to Saturday mornings 10 a. m according to availability: July, August and intermediate season. Low season, every day, minimum 2 nights.

2° The occupant has to conform to the rules of the campsite. In case of infringement the occupant is likely to be expelled and he / she won't get his / her money back from his / her initial stay.

**Absolute quietness is required from 11 p. m to 8 a.m.**

3° On leaving the chalet everything has to be clean and tidy. In case of problem, you'll have to pay € 45 for housework expenses. On leaving as well as on arriving, everything is checked.

4° No pets in the chalets, **no smoking indoors.**

5° **If people visit you, you'll have to keep the campsite manager informed.**

6° **No bed line: bring your bed sheets.**

7° **Visitors are subjected to the same daily rate as campers and they have to leave the campsite before 11 p. m.**

8° **Your accommodation will be ready from 2p. M, latest departures at 10a. m. If you leave after 10a. M** without any agreement from the manager you'll have to pay for an extra day. In so far as some chalets are free, early arrivals as well as prolonged stays may be taken into account.

9° Your booking will only be valid with our agreement and after receiving your booking form followed by **your deposit (cheque or credit transfer)** corresponding to the booking you want. You'll get **a booking confirmation.**

10° Your booking will still be valid 24 hours after the date mentioned on your booking confirmation. If you need to change the dates of your stay, we won't be able to provide you with the same accommodation.

11° In case of cancellation, you'll get back **your cheque or credit transfer corresponding to your deposit** only if the manager has been informed of your cancelling 30 days at the latest before the scheduled date of your arrival. Beyond that time limit, you won't get any refund except for any exceptional and duly justified case.

12° Cancellation charges: € 35. Charcoal as well as electric barbecues are forbidden.

13° **You'll have to pay for the remainder of your stay on arriving.**

14° You'll have to conform to the total number of persons allowed for each chalet: 4 to 6 persons, we'll only take into account the people mentioned on your booking form for any change ask us for our agreement.

15° The campsite manager won't be considered as responsible for any loss, theft or damage of any kind during or after your stay.
