## **General Rental Conditions**

- 1 ° **Reservations are made:** In intermediate season and high season July / August, the week of Saturday from 14h and before 18h to Saturday 10h according to availability. Out of season, every day of the week, minimum 2 nights.
- 2 ° The tenant is required to respect the internal regulations of the campsite. In the event that the rules are not respected, the tenant will be evicted, and his initial stay will not be refunded. **Absolute calm from 11pm to 8am.**
- 3 ° The installation must be returned in an impeccable condition. If it is incorrect, we will charge you **the cleaning fee of € 45.** An inventory is made at each arrival and each departure.
- 4 ° **Pets not allowed in the chalets, it is forbidden to smoke inside.**
- 5 ° **The Directorate must be informed of all your visits.**
- 6 ° **For any rental provide sheets.**
- 7 ° **Guests are subject to the camper rate by the day and must be out before 11pm.**
- 8 ° **The provision of rentals is from 14h and the maximum exits 10h.** Any departure after this time, without the agreement of the management, will result in the billing of an additional day. Subject to availability, early arrivals or extensions of stay may be considered.
- 9 ° The reservation becomes effective only with our agreement and after receipt of the reservation form **followed by the deposit** (check or bank transfer) corresponding to the desired reservation. **A booking confirmation** will be sent to you.
- 10 ° The reservation will be maintained only 24 hours after the date fixed. The rental amount is required from the 1st day of booking even in case of delay. For any changes to the dates of stay, the same rental cannot be guaranteed.
- 11 ° In case of cancellation, the **refund of the check or bank transfer corresponding to the deposit** can only be made if **the management has been informed no later than 30 days before the scheduled arrival date.** After this period, **no amount** will be **refunded** except in duly justified exceptional cases.
- 12 ° **Cancellation fees 35 E.**
- 13 ° Barbecues are tolerated.
- 14 ° **The balance of the stay must be paid on arrival. Holiday vouchers accepted.**
- 15 ° The total number of people admitted to the cottages must be respected. Only people named to the occupancy schedule can be accommodated, any modification must be reported.
- 16 ° The responsibility of the campsite can in no case be engaged in case of loss, theft, or damage of any kind during or after the stay.
